Assumption of Risk, Release of Liability, and Consent to Medical Treatment

As a condition of my child's participation in the Aces Soccer Camp, and in consideration for the privileges that come from participation in that camp, which may include instruction, use of facilities and equipment, and other services provided by the Aces Soccer Camps, I hereby agree for my minor child as follows:

1. I recognize and understand that the Aces Soccer Camp is a coach's camp offered and operated by Aces Soccer Camp. The camp is not a University of Evansville sponsored activity and the University of Evansville does not have any responsibility for the operation of the camp.
2. I recognize that the Aces Soccer Camp will involve various activities that may include, but are not limited to, instruction, conditioning, practices, games, meals, lodging and travel to and from Aces Soccer Camp.
3. I recognize that there are certain risks of harm to my child and others associated with my child's participation in the Aces Soccer Camp and camp activities, that there are dangers that cannot be foreseen, that there are risks and dangers that the Aces Soccer Camp and its agents and employees cannot control, and that such risks and dangers could result in bodily injury or death to my child and/or to others.
4. I understand that some of the dangers and inherent risks to my child in playing or practicing any sport include, but are not limited to, death, serious neck and spinal injuries that may result in complete or partial paralysis, brain damage, serious injury related to the eye and/or head, serious injury to virtually all internal organs, serious injury to all bones, joints, ligaments, muscles, tendons, and other parts of the muscular/skeletal system, and serious injury or impairment to other aspects of my child's body and general health and well-being. I further understand that there are risks associated with travel and that my child could incur some or all of these injuries during travel to and from the Aces Soccer Camp.
5. I acknowledge that the Aces Soccer Camp has strongly recommended to me that my child seek medical advice concerning his/her physical health, conditioning and abilities prior to engaging in any camp activities. I further acknowledge that my child does not have any medical conditions that would affect his/her fitness to participate in camp activities.
6. I agree that if any injury or emergency should occur during camp with respect to my child, the Aces Soccer Camp staff is authorized to take whatever steps are reasonably necessary in their judgment to attend to my child's medical needs. I agree to be responsible for any hospital expenses, doctor's bills, or other expenses that may be incurred to attend to my child's medical needs.
7. I represent that my child has adequate health insurance to cover the cost of treatment in the event of any injury he/she incurs during participation in the Aces Soccer Camp.
8. I agree to assume all risks and responsibility for any and all claims for damages including personal injury or death, medical expenses, disability, lost wages, loss of earning capacity and property damages that may be incurred by my child while engaged in camp activities.
9. I, on behalf of my child, my personal representatives, heirs, executors and assigns, agree to hold harmless Marshall Ray, Aces Soccer Camp, and the University of Evansville and their agents and employees from any and all liability, including claims, demands, causes of action (known or unknown), suits or judgments of any and every kind (including attorney's fees), arising from any injury, property damage, or death that my child may suffer as a result of participation in the Aces Soccer Camp, regardless of whether the injury, damage, or death is caused by the Aces Soccer Camp or otherwise, unless the injury, damage, or death is caused by the Aces Soccer Camp's negligence, gross negligence, or intentional misconduct.
10. I further agree that in the event that I or any of my family members, personal representatives, heirs, executors and assigns, or any other third party attempts to assert any claims, demands, causes of action (known or unknown), suits, or judgments of any and every kind (including attorney's fees), arising from any injury, property damage, or death to my child, including but not limited to any injury resulting from my child's

own negligence, gross negligence, or intentional misconduct during or related to the Aces Soccer Camp activity, I agree to defend and indemnify Marshall Ray, Aces Soccer Camp, and the University of Evansville against such claims, demands, causes of action, (known or unknown), suits, and/or judgments of any and every kind (including attorney's fees) to the fullest extent permitted by law. In signing this release, I acknowledge and represent that I have carefully read the foregoing, that I understand it, and that I sign it voluntarily as my own free act and deed. No one has made any oral representation, statement, or inducements in order to get me to sign this document. I have had the opportunity to consult with my own legal counsel before signing this document.

I acknowledge that I am the guardian or parent of the participant who is less than 18 years of age and that I understand the terms of this agreement. This agreement shall be binding upon the participant and the participant's parents, guardians, heirs, and personal representatives.

Full-Day - \$215 (9:00 a.m. - 4:00 p.m.)

All campers receive an Aces Soccer Camp T-shirt and a certificate of achievement. Full-day camp includes a lunch and drink.

Program

Day Camps - Boys and Girls Grades K-6

- These camps are specifically designed to teach fundamental skills.
- Campers are grouped by age and ability.
- Morning session includes skill training and development, and concludes with scrimmage matches.
- Full-day campers have lunch before attending the afternoon sessions.
- A certified CPR and first aid staff member is always on duty.

Dismissal

- Half-day campers are dismissed promptly at noon on the field with their coach.
- Full-day campers are dismissed promptly at 4:00 p.m. on the field.
- All campers are required to be checked out by a parent with their assigned coach.
- No child will be allowed to leave the field without being signed out.
- Closing ceremony will take place on Thursday at noon for the Day Camps and on Friday at noon for the Advanced Day Camp.

Facilities

The Aces Soccer Camp is located at Arad McCutchan Stadium on the University of Evansville campus. The entrance is located off the Arad McCutchan Stadium parking lot on Frederick Street. Bathrooms and indoor space for shelter from severe weather are available.

Weather

Camp will be held RAIN or SHINE.

- If it is raining during morning drop-off, please bring campers inside Carson Center to the Large Gym (across from the ticket window).
- If it is raining during pick-up times, campers will be dismissed from Carson Center.
- In case of severe weather, the campers will be brought inside to the nearest shelter, which could be Carson Center or inside Arad McCutchan Stadium.

Check-in

- Please contact the Aces Soccer Camp staff if your child will not be attending camp or will be late (314-488-9366).
- Check-in will begin 30 minutes prior to the start of camp at the entrance to Arad McCutchan Stadium.
- After 1st day, coaches will take attendance on the field every morning.

Apply!

Please label all personal items. Aces Soccer Camp is not responsible for lost or misplaced items.

- Needed items - shin guards, ball, cleats and sneakers (in case we need to use indoor gym)
- Suggested items - water bottle (water is provided on the field at all times), mid-morning healthy snack, change of clothes and socks, jacket, sunscreen and mid-afternoon snack for full-day campers

Concession

- A small concession stand will be available during the morning session only.
- Water coolers are available at all field locations at all times.

Discipline Policy

Aces Soccer Camp has a zero-tolerance policy for bullying, physical fighting, inappropriate behavior (verbal or physical), and anything the director deems harmful to other campers. The director has the right to expel campers immediately for these actions.
